
- 1. Name of the company: This company is named as" Sahayogi Foundation".

- e. Develop activities of elder and informal classes ensuring women participation in different development activities of Nepal.
- f. Operate other several programs in social services obtaining the approval of concerned local officer.
- g. Conduct educating programs concerned to modern education to helpless, orphan and poor children from different communities of Nepal.
- h. Educate the children from every community in Nepal through their mother language as far as practicable for the protection and promotion of local language, culture, civilization and heritage.

- m. Manage for the educational development of children from backward community according the policy "education for all".






- n. Make separate group and section of children for their development by the decision of institution promoters.
